

# **Sustainable Solano Volunteer Liability Waiver and Agreement**

**(Please read carefully)**

## **Volunteer agrees:**

2. At this Event, I agree to follow all safety directions, supervise any other person for whom I am responsible for, and alert Sustainable Solano if I become aware of any hazardous condition.
3. **Assumption of Risk.** I understand the Activities include work that may be hazardous to the myself, including, but not limited to, construction, loading and unloading, and transportation to and from the work sites, and those caused by terrain, facilities, soil conditions, temperature, physical exertion, insect/rodent exposure, chemical exposure and actions of other people.
4. **Release and Waiver.** I hereby expressly and specifically assume the risk of injury or harm in participating in Activities and in consideration for my participation in this Event, I waive and release any and all claims against: Sustainable Solano; and Sustainable Solano’s directors, officers, agents, employees, volunteers and affiliates (collectively, the “Released Parties”), for any liability, loss, damages, claims, expenses and attorneys’ fees resulting from death, or injury to my person or property, caused by or arising directly or indirectly from my presence at this Event or participation in Activities, regardless of the cause and even if caused by negligence, whether passive or active. I agree not to sue any of the Released Parties on the basis of these waived and released claims. I waive the protections of Section 1542 of the California Civil Code, which provides that a general release does not extend to certain claims not known to me at the time I signed this waiver and release.
5. **Medical Treatment.** I understand that Sustainable Solano does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness. I hereby release and forever discharge Sustainable Solano from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with my Activities with Sustainable Solano.
6. **Insurance.** I anticipate no payment of any kind for my participation in this Event and agree Sustainable Solano does not carry any type of insurance coverage for any Volunteer or for which I am eligible.
7. **Photographic Release.** I hereby grant and convey unto Sustainable Solano all right, title, and interest in any and all photographic images and video or audio recordings made by Sustainable Solano during this Event, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.
8. **Other.** I expressly agree this Release is intended to be as broad and inclusive as permitted by the laws of the State of California, and this Release shall be governed by and interpreted in accordance with the laws of the State of California. I agree that in the event that any clause or provision of this Release shall be held to be invalid by any court or competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
