I, _____, AGREE to participate voluntarily in ongoing planting and maintenance of Benicia **Community** Orchard (BCO), the program of Sustainable Solano, in 2023-24 growing seasons;

I UNDERSTAND that the annual membership fee of \$125. The annual non-refundable fee is due at the beginning of each growing season, by March 21, payable to Sustainable Solano.

I UNDERSTAND that BCO Membership Agreement is an annual agreement, which expires each year on March 20; and, if I want to continue my participation in BCO, I will sign a new Agreement by March 21;

I UNDERSTAND that being a member requires me to do a minimum of 6 hours of work per year;

I AGREE to immediately notify the volunteer BCO coordinator if for whatever reason I can no longer participate in BCO;

I AGREE to abide by the Founding Principles of the Orchard and by BCO Rules & Regulations;
